## 2017 Watering Regulations

The District will be actively enforcing the District's Water Regulations Bylaw. We appreciate your attention to these water conservation measures and thank you for your cooperation in this regard. Please contact the GEID office should you have any questions.

Water Conservation Measures in Effect for all Customers in the Glenmore, Ellison and McKinley Landing Areas	
Residential Properties	<ul> <li>The last digit of the street address determines even or odd day watering.</li> </ul>
	<ul> <li>Odd-numbered properties may water on Tuesday, Thursday, or Saturday.</li> </ul>
	<ul> <li>Even-numbered properties may water on Wednesday, Friday, or Sunday.</li> </ul>
	<ul> <li>No watering permitted on Mondays (city wide).</li> </ul>
	<ul> <li>Portable above–ground sprinklers: Only two portable sprinklers per residential lot are allowed and watering is only allowed between the hours of 6:00 a.m. to 10:00 a.m. and 7:00 p.m. to 12:00 a.m. up to three days per week.</li> </ul>
	<ul> <li>Underground sprinklers may only be operated during the hours of 12:00 a.m. (midnight) to 6:00 a.m. up to three days per week.</li> </ul>
	Open hose use is not permitted; the hose must have a nozzle to control flows.
	<ul> <li>Sprinkling must be kept within the property boundaries and may not adversely affect other properties; sprinkling on driveways and sidewalks is not permitted.</li> </ul>
	<ul> <li>Excessive sprinkling that the flow or drainage impacts other properties is not permitted.</li> </ul>
	<ul> <li>Car washing is to be done with a bucket. A nozzle on the hose is to be used to control the flow for rinsing.</li> </ul>
	Driveway washing is not permitted.
	Potted plants may be watered daily.
Strata Complexes and Multi–Family Units	The entire complex may water based on the civic address, not by unit number. Strata's are to follow residential property watering restrictions, unless given specific permission from GEID to do otherwise.
Agricultural Properties	<ul> <li>Agricultural users are reminded that for any lawn areas that are being irrigated from the house connection to follow residential property watering restrictions, unless given specific permission from GEID to do otherwise. Dole valves must be used to control irrigation watering.</li> </ul>
Industrial and Commercial Properties	<ul> <li>Watering is allowed between 6:00 a.m. to 10:00 a.m. and 7:00 p.m. to 12:00 a.m. up to three days per week.</li> </ul>
	Odd address schedule: Tuesday, Thursday and Saturday.
	■ Even address schedule: Wednesday, Friday and Sunday.
